1. Project Overview

The Kingsburg Athletic Foundation, in coordination with the High School District and Athletics Department, is seeking the support and partnership of the Kingsburg HealthCare District to purchase a new Wrestling Mat. The Wrestling Mat will be used by both our High School student-athletes, as well as our Youth Programs totaling approximately 100 wrestlers in the community of Kingsburg.

Currently (see attached picture), the top layer of our Wrestling Mat has numerous depleted areas which has exposed the foam base. The condition does not allow for repair and more importantly does not allow for the proper sanitation of the Mat. During the past few seasons, our student-athletes have dealt with both bacterial and fungal infections of impetigo and ring worm which are serious infections caused by the inability to properly clean the exposed foam prevalent throughout the entire Mat.

2. Project Cost = \$24,070.03
